Conditions of Sale

- The deposit to reserve a kitten is non-refundable. Deposit is included in the sale price.
- Seller guarantees that this kitten/cat is healthy to the best of her knowledge, FeLV/FIV negative, and free from any life threatening illnesses, infections, or parasites at the time of sale. Any and all veterinary costs are the responsibility of the buyer.
- During this first 72 hours the kitten should be isolated from any other pets and monitored for health, eating, litter box usage and activity level.

- The kitten/cat will not be mistreated, and will have fresh food, water and a clean litter box at all times. The kitten/cat will receive frequent and kind human attention. The kitten/cat will be provided with scratching post or cardboard scratchboard, as well as plenty of toys.
- Under no circumstances will this kitten/cat be sold, leased or given away to any pet store, research laboratory, breeding mill or similar facility. In the event that the Buyer can no longer keep the kitten/cat, the Breeder will be contacted immediately as a first option to assist in the placement of the animal.
- This kitten/cat will be kept indoors and not be allowed to roam freely outdoors. The kitten/cat will not be allowed outside except on a leash (under close supervision), or in a completely enclosed run. The kitten/cat will not be caged, or kept in an unsuitable room.
- This kitten/cat will not be declawed. If this kitten/cat is found to be neglected or mistreated, the Buyer will surrender said kitten/cat to the Breeder or the Breeder's representative unconditionally.
- If kitten/cat death occurs within 2 years of purchase date due to an inherited genetic disease, buyer must inform seller and provide a necropsy from a licensed veterinarian. Seller will then offer a replacement kitten up to the amount of original purchase when one becomes available. No monetary refunds will be offered. Health guarantee will not be honored if ownership changes. The health guarantees and kitten replacement will become void if Breeder is no longer breeding.
- This kitten is required to be spayed/neutered by the age of 6 months, if not spayed/ neutered by the breeder. If this kitten is not spayed/neutered by 6 months of age, this contract will be null and void. Registration papers will be released to the buyer after a proof of spay/neuter document is received by the breeder.
- Final balance payment will be due by the date specified by the breeder. Final balance must be cleared before any shipping arrangements are made by the breeder.
